
In June 2017 the MSC issued MSC.428(98) which requires that cyber risks are appropriately addressed in ISM safety management systems.

What

Companies operating approved SMS must ensure that IT systems are risk assessed – including systems used to operate the vessel – and procedures put in place to manage all cyber security risks.

Where

The requirement applies to all vessels in operation and company infrastructure ashore. Due to cyber threats from external sources this includes interactions with suppliers, customers, port operators, agents, regulators and other third-parties.



When

All risk assessments, procedures and training need to be completed before the first annual verification of the company's Document of Compliance after 1 January 2021.

Why

There have been several high-profile security attacks on large shipping companies in recent years, as well as speculation in the global press regarding ship cyber attack vulnerabilities and the potential catastrophic consequences.




